

Application for grant of NOC for Power Projects

Frequently Asked Questions

- **What is “Application for Grant of NOC for Power Projects ”?**

This portal allows organizations/firms/companies/individuals to apply online for security clearance/NOC for construction of **Power Projects/WTGs/Solar Power projects (except solar power modules at the top of building for domestic usage)** .

- **What is the objective of this application?**

“Application for Grant of Permission for constructions of **Power Projects/WTGs/Solar Power** ” is developed to reduce the time consumed for grant of NOC. It is aimed to bring in more transparency, accuracy and speedy disposal of application for NOC.

- **Are there any specific guidelines for working on this application?**

Detailed guidelines for using the application are attached on the homepage. Users can click and download the same for their reference and needful action.

- **Is it allowed for a single user to create multiple applications?**

One organization can create multiple applications. Single mobile number of the authorise person will be sufficient to apply online.

- **Who needs to apply through this portal?**

Any organizations/firms/companies planning to carry out constructions of **Power Projects/WTGs/Solar Power** near Ministry of Defence Installation within Indian boundaries is required to obtain NOC by applying through this portal.

- **Is this portal for only Indian companies? How can a foreign company apply for grant of permission?**

This portal can be utilized by any agency/firm including foreign entity who is authorised/hired by GOI organisation/State Government/PSU/Autonomous bodies, for carrying out constructions of **Power Projects/WTGs/Solar Power** .

→ Who is entitled to be nodal officer for my application?

Any permanent employee of the organization duly authorised to take/convey decision can be the Nodal officer.

→ What is the maximum number of Geo Coordinates allowed in a application ?

There is no limit for the number of Geo Coordinates in a application.

→ What minimum number of Geo Coordinates I need to add in my application?

Minimum number is 1.

→ What will happen, if application is incomplete?

There are some fields which are required to be filled up mandatorily and without which the application will not be processed further.

- What is the Role of Sponsoring Ministry/Organisation ?

Ministry of Defence accepts application from any Agency/Applicants duly authorized by the Sponsoring Ministry of Government of India /State Government Agencies/Autonomous Bodies .An indicative matrix showing the type of applicant and its sponsoring ministry/organization is given below for reference. The same is as per the instruction of the competent authority and subjected to change as per the further notification issued by MoD.
